What was done

The certification process began in early 2021. Having held PAS 1192-2 BIM Certification Scheme for Businesses for many years, Waldeck already had much of the required documentation in place. The documents needed updating to encompass ISO terminology and restructuring/expanding upon areas to cover BRE scheme requirements.

Having submitted their BIM Standards, Methods and Procedures, BIM documentation and templates, the next step was the assessment from BRE's expert auditors. Audits of Waldeck's processes, undertaken remotely due to the global pandemic, allowed BRE to assess Waldeck's information management process through appointments. Veronica Ruby-Lewis said, "As with previous audits, BRE were comprehensive when reviewing both organisational and project documentation which further bolsters the continuation upholding of our certification".

By July 2021, the assessment process was complete, and shortly after, Waldeck had achieved ISO 19650-2 certification.

Project outcome

Achieving ISO 19650-2 certification requires a commitment to delivering excellence from across the organisation, which was evident in Waldeck's accomplishment.
